Draft letter to Charity Commission about redistribution of funds

With a minor amendment, the trustees approved the letter, drafted by Nick Smith of Villars Hayward and the general secretary, for submission to the Charity Commission, requesting approval to close the Buxton Fund and the Creech Jones Fund and transfer the money to the general fund and the Candy (Restricted) Fund respectively.

REVIEW OF COMMITTEES, WORKING PARTIES, TERMS OF REFERENCE AND MEMBERSHIP

The trustees considered the terms of reference and membership of the committees, subcommittees, and working parties. They agreed the following.

The trustees also approved the documents regarding terms of grants from the legalaction fund, as recommended by the legal committee.

Eversley Award: Terms of reference approved. Membership: John Hall, Kate Ashbrook

AGM 2026 FORMAT

The trustees considered the format for the 2026 AGM in the light of the feedback from the AGM itself. They agreed unanimously to continue with the hybrid format in 2026, but to review this annually. The general secretary said that we had made a provisional booking at Friends' House for Thursday 2 July 2026, and this would now be confirmed.
